All applicants are expected to be financially capable of supporting themselves during the participation of this programme.

Terms and Conditions for Successful Application

成功申请的条款和条件

A) Successful applicants:

- Are strictly forbidden from participating in activities which are sensitive to local people, politics, missionary and activities that are provocative, investigative in nature and sensitive that could threaten to the security of the country
- Are required to maintain a minimum balance of RM250,000.00 in the SMM2H fixed deposit account in panel banks only.

B) 30 days minimum stay requirement

All main participants are required to stay at least 30 days every year in Sarawak as one of the condition for consideration of extension and renewal of SMM2H programme.

A) 成功申请者：

B) 至少逗留30天的要求

所有主要参与者每年必须至少在砂拉越逗留30天，这是SMM2H计划申请延期和续签的条件之一。

Requirement on Work/Investment

- SMM2H participants are not eligible to work full time
- SMM2H participants are only eligible to work part time in professional jobs in sectors approved by the ILMU through MTCP
- Total working hours must not exceed 20 working hours per week
- SMM2H participants are allowed to be "Minority partner" in Joint-venture (JV) business with local partner in sectors approved by ILMU. SMM2H participants can own up to 49% of the total paid-up capital of RM250,000 (minimum).
- All applications to work under SMM2H Programme must be made to the State Authority.

* Professional sector:

Education, Banking/Securities, Manufacturing and Medical.

Applications must be made through MTCP to the approval committee under State Secretary.

SMM2H Processing Fee

All applicants are required to pay **one-time processing fee of RM5,000.00** to the Ministry of Tourism, Creative Industry and Performing Arts Sarawak (MTCP). The application will be processed upon receipt of the processing fee and submission of all required documents. This processing fee of RM5,000 is non-refundable.

How to Withdraw Fixed Deposit (FD)

Please submit the following documents to the Ministry of Tourism, Creative Industry and Performing Arts Sarawak:

- Letter of Intent from Applicant
- Copy of Approved SMM2H Conditional Approval Letter
- Copy of Applicant's Passport (Applicant's Personal Details and Multiple-Entry Pass Page)
- Copy of Latest Fixed Deposit with the bank address and the account number
- Proof of Payment or any Supported Documents

House Purchase

Property purchase is optional for all applicants. The approved participant is allowed to purchase a residential house in Sarawak with value at least RM600,000 (Kuching Division) and RM500,000 (other Divisions) subject to Land Code (Amendment)(No.2) Order 1998 & Land (Market Value of Property for Foreign Acquisition) Direction 1998.

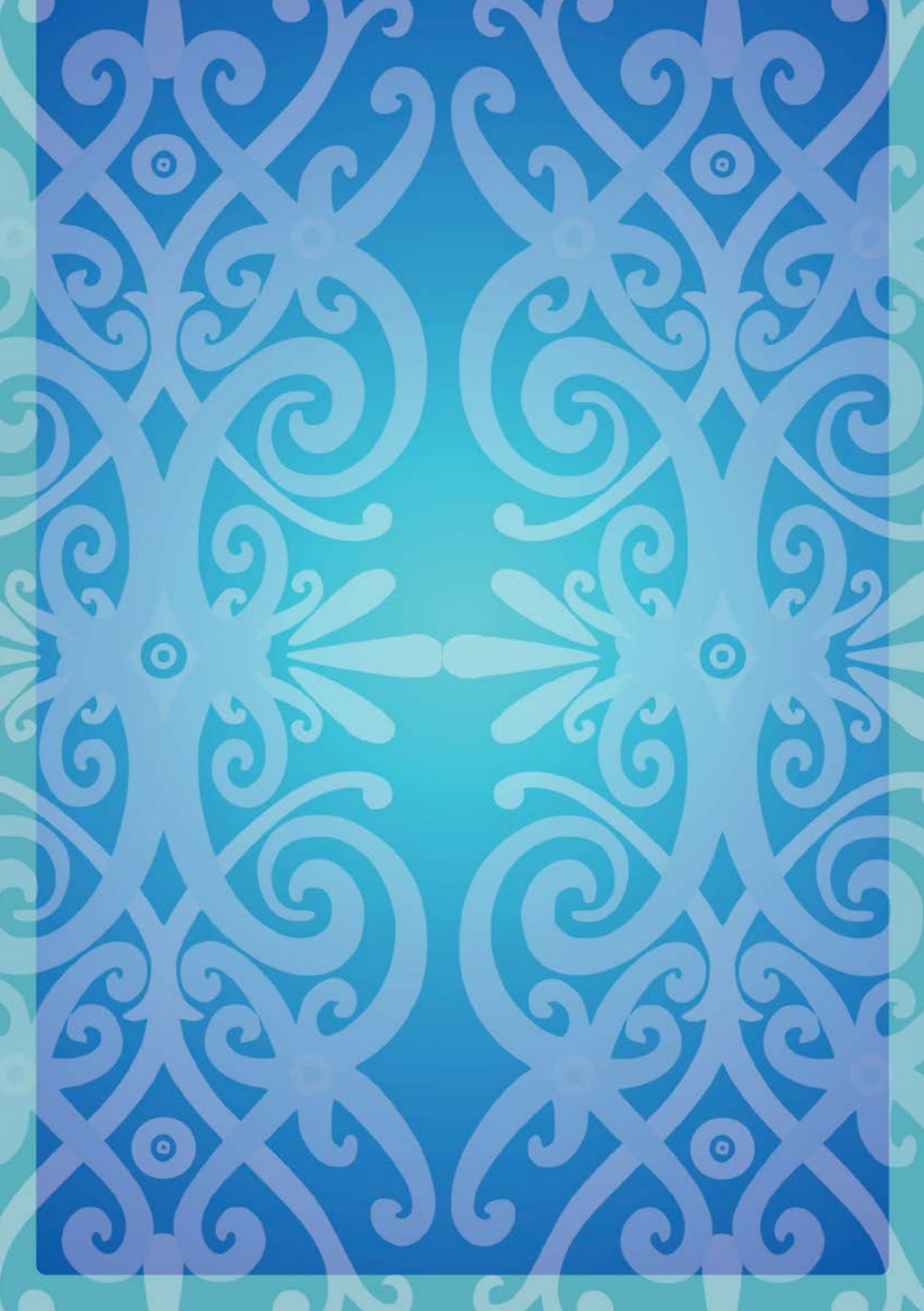
